

User Access Agreement for Checked by NSF App (“Site”)

NOTICE TO USER: READ THE FOLLOWING USER ACCESS AGREEMENT CAREFULLY BEFORE USING THIS SITE. THESE TERMS AND CONDITIONS GOVERN YOUR ACCESS TO AND USE OF THIS SITE AND BY ACCESSING, VIEWING OR USING THIS SITE YOU ACKNOWLEDGE THAT YOU HAVE READ, FULLY UNDERSTAND AND AGREE TO BE BOUND BY ALL OF THESE TERMS AND CONDITIONS.

1. Site and Program Ownership: This Site is owned and operated by NSF International Food Safety, LLC and its affiliates (“NSF”).

2. Acceptance of Terms and Conditions By Your Use: By using this Site, you signify your agreement to all of the terms and conditions contained or referenced in this User Access Agreement ("Terms and Conditions"). NSF reserves the right to amend these Terms and Conditions from time to time. Your continued use of the Site following the posting of any amendments to these Terms and Conditions constitutes your acceptance of those changes and NSF has no obligation to inform you of such changes in any other manner.

3. Definition of Certain Terms In these Terms and Conditions: “Subscriber” means the party who contracted with NSF for a license to access this Site and who has been granted access to this Site in connection with such license. “You” means the individual accessing the Site pursuant to the Subscriber’s license. “Data” means any and all information entered by you on the Site.

4. Permitted Uses: Use of this Site is strictly limited to the Subscriber. 13. **Invalidity:** If any of these Terms and Conditions is adjudged to be invalid, void or unenforceable, the remaining Terms and Conditions will not be affected thereby. Such invalid provision may be replaced by the lawful provision that most nearly embodies the original intention of the parties as expressed herein, and these Terms and Conditions will in any event otherwise remain valid and enforceable.
